

## REQUEST FOR EXEMPTION FROM CERTAIN VERIFI REQUIREMENTS

## **INSTRUCTIONS**

## To REQUEST AN EXEMPTION

- 1. Determine whether your facility qualifies for an exemption from using the VERIFI system to get electronic Certificates of Sale (MV-50) and from certain book of registry requirements. According to §78.9 of the Commissioner's Rules and Regulations, to qualify for an exemption, your facility must meet **ALL** of the following requirements:
  - Your facility sold fewer than 10 vehicles in the last 12 months.
  - Your dealership has two or fewer dealer demonstration and transporter plates.
  - Your facility is <u>not</u> in the Dealer Partnering Program or the Dealer Plate Issuance Program.
  - Your dealership's registration was <u>not</u> suspended on any day starting on or after March 23, 2016.
  - Your facility was placed into business before October 9, 2018.

IMPORTANT: If you do not meet ALL of the requirements listed above, your application will be rejected.

- 2. You must register with the VERIFI system and complete a VERIFI Facility Participation Agreement. To get the agreement, go to www.VERIFINY.com, or call the VERIFI Help Desk at (833) 837-4346.
- 3. After you complete the VERIFI Facility Participation Agreement, you may request the exemption. To request the exemption, complete sections 1, 2, 3 and 4. Send the completed and signed form to DMV by mail or fax (do not fax and mail the application, choose only one method):

## To REQUEST WITHDRAWAL OF AN EXEMPTION
